

USC Sections regarding shipping of automatic opening knives

18 USC 1716 (g) (2) (1-4)

Summary: Automatic opening knives (switchblades) can be shipped (1) to civilian or Armed Forces supply or procurement officers and employees of the Federal Government ordering, procuring, or purchasing such knives in connection with the activities of the Federal Government (2) to supply or procurement officers of the National Guard, the Air National Guard, or militia of a State ordering, procuring, or purchasing such knives in connection with the activities of such organizations; (3) to supply or procurement officers or employees of any State, or any political subdivision of a State or Territory, ordering, procuring, or purchasing such knives in connection with the activities of such government; and (4) to manufactures of such knives or bonafide dealers therein in connection with any shipment made pursuant to an order from any person designated in paragraphs (1), (2), and (3).

15 USC 1244 (2-4)

Summary: Automatic opening knives (switchblades) can be shipped (1) any common carrier or contract carrier, with respect to any switchblade knives shipped, transported, or delivered for shipment in interstate commerce in the ordinary course of business; (2) the manufacture, sale, transportation, distribution, possession, or introduction into interstate commerce, or switchblade knives pursuant to contract with the Armed Forces; (3) the Armed Forces or any member or employee thereof acting in the performance of his duty; or (4) the possession and transportation upon his person, or any switchblade knife with a blade three inches or less in length by any individual who has only one arm. –
